Subject: Request for disqualification of leader of opposition Ms Atishi from the legislative assembly and recommendation for registration of a criminal case against her for her blasphemous remarks against the Guru Sahiban.

Hon'ble Speaker Sir,

As you are aware, Smt. Atishi, a Member of the Legislative Assembly, Delhi, has made outrageous and sacrilegious remarks against the revered Sikh Guru Sahiban.

These remarks have grievously hurt the religious sentiments of the devout, brave and patriotic Sikhs across the world.

I approach you as both the President of the Shiromani Akali Dal as well as a devout Sikh who is anguished by the sacrilegious remarks against the universally revered Sikh Guru Sahiban.

The Sikh Guru Sahiban embody the eternal spiritual sovereignty of Akal Purakh and the collective allegiance of the Khalsa Panth to the eternal goals of cosmic truth and universal brotherhood, cutting across caste, creed or race or religion, language or regions. The Khalsa Panth derives its divine inspiration and authority from Sri Guru Granth Sahib Ji, the eternal living embodiment of Guru Sahiban.

As such, Ms Atishi's deeply hurtful remarks against the Sikh Guru Sahiban constitute religious blasphemy (beabbi) under Sikh religious doctrine and is deemed by every Sikh as affront to their spiritual identity.



In addition, these remarks are wilful, malicious, premeditated and calculated to hurt the religious sentiments of the Sikh community.

In view of these facts I humbly request you to recommend registration of an FIR against Smt Atishi under Section 299 of the Bharatiya Nyaya Sanhita for hurting religious sentiments and Section 196 BNS for promoting enmity and disharmony between communities.

From a legislative standpoint, the conduct of Smt. Atishi constitutes a grave breach of privilege and contempt of the House, amounting to conduct unbecoming of a legislator. A Member who publicly insults the faith, Guru Sahib and religious sentiments of the minority Sikh community forfeits not only moral legitimacy but also constitutional right to remain a lawmaker.

I must also place on record that the matter has evoked serious concern within Panthic institutions, headed by the supreme religio-temporal authority of the Sikhs, Shri Akal Takht Sahib.

In addition, these provocations pose a serious danger to the hard earned atmosphere of peace and communal harmony in Punjab and the rest of the country.

In the light of the above, I formally request you to take appropriate steps to disqualify Ms Atishi as a Member of the Legislative Assembly, Delhi. I have no doubt that you will accord utmost seriousness and priority to the issue and set an example for future generations so that our country becomes a symbol of respect for all faiths, especially the minority communities.
